
MASSC GROUP INSURANCE SCHEDULE

HEALTH INSURANCE:

Effective October 1, 2011, the College will contract with health insurance carriers to provide health insurance coverage for MASSC (managers, administrators, supervisors, specialists and confidential) employees according to *APP 7031 MASSC Group Insurance*.

Premiums are subject to rate changes. Through a payroll deduction, employees shall pay any difference in cost between the necessary premiums and the College's contribution. Contributions may be adjusted annually.

The College shall follow the same schedule of employer contributions as outlined for the Classified and Faculty staff.

DISABILITY AND LIFE INSURANCE:

Long term disability insurance and term life insurance shall be continued at no less than the benefit level in effect on July 1, 1993 until this procedure is superseded or revised. Basic life insurance shall be for the employee only at \$100,000. Accidental Death & Dismemberment shall be for the employee only at \$100,000.

The College shall pay all long term disability and life insurance premiums for eligible Full-Time employees for the coverage in effect.
